So far, we have raised and invested over £30 million into Scotland's built heritage, and further leveraged our resources by working in partnership with others, sharing our expertise to ensure the best outcome for their own projects.

Key Responsibilities

1. Strategic Leadership and project delivery

- Oversee the identification and delivery of projects including appraisal, acquisition, funding, design, procurement and delivery of construction through to final occupation liaising with all stakeholders through the whole process.
- Develop and implement the overall strategic direction of the Trust, in collaboration with the Board of Trustees.
- Provide strategic leadership and oversee effective governance practices to ensure the organisation's sustainability and growth while maintaining compliance with relevant regulations.
- Create and communicate a compelling vision and mission for the Trust's building preservation and heritage conservation efforts.

2. Financial Management:

- Manage the Trust's financial resources, and oversee budgeting, forecasting, and financial reporting.
- Develop and implement strategies to generate sustainable income and ensure the financial viability of the Trust.
- Oversee grant applications and funding proposals to secure financial support from various sources, including the Heritage Lottery Fund and Historic Environment Scotland.

3. Building Conservation and Heritage Preservation:

- Use your knowledge and expertise in building conservation and heritage preservation to ensure best practices are followed in the maintenance, restoration, and preservation of the Trust's buildings.
- Collaborate with heritage experts, architects, and contractors to develop and oversee conservation projects, ensuring compliance with relevant regulations and standards.


